Clerked for Judge Nathaniel R. Jones of the US Court of Appeals for the Sixth Circuit. Practiced law in Washington, D.C. and Norfolk, Virginia. In 1995, joined the faculty at William and Mary School of Law. Received the Alumni Fellowship Award in 2000 and the Walter L. Williams, Jr. Teaching Award in 1998 and 2005. Elected member of the American Law Institute and of the American Bankruptcy Institute and American Bar Association.
